## 1. Legal framework

### 1.1. This policy has been created with regards to the following guidance:

- School Food Plan 'School Food Standards' 2015
- DfE 'School food in England' 2016

## 2. Aims and objectives

### 2.1. While maintaining this policy, [Rothbury First School](#) aims to:

- Promote the benefits of healthy eating and its effect on performance at school.
- Offer parents with clear guidance on providing a healthy packed lunch.
- Ensure that the standards of packed lunches comply with the current nutrition standards of school lunches.
- Improve the quality of packed lunches that pupils consume.

### 2.2. To comply with our healthy eating policy, parents are required to:

- Provide pupils with healthy packed lunches containing recommended food groups.
- Inform children of the importance of healthy eating.

## 3. Food and drink in packed lunches

### 3.1. Based on the School Food Standards, packed lunches which children bring to eat at [Rothbury First School](#) should contain the following:

- One portion of fruit, vegetable or salad
- Meat, fish or another source of non-dairy protein
- Carbohydrates, such as bread, pasta, rice or potatoes
- Dairy, such as cheese, yoghurt or custard
- An oily fish will be included at least once every three weeks
- Only water, fruit juice, milk, yoghurt drinks or smoothies

### 3.2. As part of our [Healthy Eating Policy](#), all packed lunches prepared by the school will contain a balance of foods from each food group.

### 3.3. Packed lunches should contain snacks that comply with [Rothbury First School's](#) healthy eating policy – these may include, but are not limited to the following:

- Chopped vegetables, carrot or celery sticks
- A portion of fruit

- Breadsticks

**3.4. To allow for the promotion of healthy eating, we request that the following food and drinks are not included in your child's packed lunch:**

- Chocolate bars
- Other confectionery items such as sweets or chewing gum
- Carbonated drinks or those containing high levels of caffeine

**3.5. The following may be included no more than twice a week as part of a balanced diet:**

- Individual meat pies, sausage rolls and corned beef, to limit salt intake
- Plain biscuits and cakes, to limit sugar intake

## **4. What the school will provide**

- 4.1. In accordance with DfE's guidance 'School food in England' 2016, [Rothbury First School](#) will ensure that pupils have access to free, fresh water at any time.
- 4.2. Clean dining areas are available for all pupils; [Rothbury First School](#) will aim to prevent segregation of packed lunch and school dinner pupils.
- 4.3. Advice for parents regarding our policies and healthy eating regulations will be available at all times.
- 4.4. Staff and catering members will support families to ensure the packed lunches they provide are healthy.

## **5. Monitoring and review**

- 5.1. The [headteacher](#) will review this policy annually, and ensure that all procedures remain current and up to date.
- 5.2. The governors will work with the school to review the packed lunch policy and provide advice and support where needed.
- 5.3. Any changes to government guidance regarding school food standards may lead to changes in this policy.
- 5.4. All parents and staff will be notified of any changes made to this policy.
